

**2009-2010 Puget Sound Region  
CLUB-PLAYER CONTRACT**

THIS AGREEMENT is made between Moxie , a licensed Club (the “Club”) in the Puget Sound Region (the “Region”) of the United States Volleyball Association, (“USAV” or “USVBA”) , and \_\_\_\_\_ , the legal parent/guardian of \_\_\_\_\_ , a junior player (the parent/guardian and the player are collectively referred to as the “Member”).

**The Member will:**

- 1) abide by USAV rules, regulations and polices which include the USVBA Participant Code of Conduct, the Coaches Code of Ethics and Conduct USVBA;
- 2) abide by the Region’s rules, regulations, and policies; and
- 3) pay all fees and costs associated with membership in the Club as described in Appendix C.

**The Club will:**

- 1) abide by USAV rules, regulations and polices which include the USVBA Participant Code of Conduct, the Coaches Code of Ethics and Conduct, USVBA;
- 2) abide by the Region’s rules, regulations, and policies;
- 3) deliver the volleyball education, training, and playing opportunities described in Appendix A; and
- 4) provide the ancillary items described in Appendix B.

*I certify that I am the legal parent/guardian of player, \_\_\_\_\_, and have the authority to agree and sign this contract and waiver on behalf of the player. I acknowledge that participation in this athletic activity can result in serious injury or death to participants and agree to indemnify, defend and hold harmless the Club and the Region for any and all claims for harm or injuries suffered during participation in Club activities, including but not limited to play and practice. I further agree to waive and release the Club from any all demands, claims, actions, lawsuits, liability and damages of any kind arising from participation in the Club activities. I agree that prior to filing any lawsuit against the Club, the Region or USVBA, I must attempt to resolve my claim via mediation and arbitration in accordance with RCW 7.04A in Snohomish County, Washington..*

## **Appendix A**

Teams will practice for 1.5 hour “on court” sessions. The coach may request you to arrive early or stay after for additional work. It is reasonable to expect that you may spend 2 hours of total time in the gym. There will be at least one tournament / month scheduled on a non-holiday weekend. Additional tournaments can be added at the discretion of the coach and based on player availability as well as club budget allowances.

## **Appendix B**

Club dues will cover USAV membership for yourself, coaches stipends, region mandated referee/scorekeeper clinic, teambuilding activity, gym rental for practice two times a week for 1.5 – 2 hours per practice session, tournament entry fees, 2 jerseys and warm-up set.

## **Appendix C**

Dues for the 2009-2010 season are \$800. They can be paid in full up front, or in installments. If they are paid in installments, they are due in \$200 payments on the 1st of December, January, February, and March.
